- 3. The price you pay to STQ for your ATV/UTV trip includes the following:
 - Upper Laurentians Saddlebag Trip a guide for each day of the trip, hotel accommodations (single or double occupancy as selected above) that have been arranged by STQ for each day of the trip, and breakfast and dinner as provided by each hotel as part of the accommodation package. The Participant is separately responsible for paying for the following during the ATV/UTV trip: gasoline for your ATV/UTV; lunches; and the cost for any incidentals or beverages (including alcoholic beverages) purchased. Tips for your guide at the end of the trip are greatly appreciated, but are not required.
 - Gaspe Peninsula Saddlebag Trip a guide for each day of the trip, and hotel accommodations (single or double occupancy as selected above) that have been arranged by STQ for each day of the trip. Hotel accommodations for this trip do not include breakfast or dinner. STQ has lowered its price of this trip to reflect that the Participant will be solely responsible for the cost of his or her breakfast and dinner at each hotel. The Participant is separately responsible for paying for the following during the ATV/UTV trip: gasoline for your ATV/UTV; lunches; and the cost for any incidentals or beverages (including alcoholic beverages) purchased. - 4. Participant is responsible for providing his or her own ATV or UTV, as well as safety gear (helmets, gloves, protective eyewear, footwear and clothing), for Participant's use during the trip. Participants and their ATVs and UTVs must comply with the size, weight, and safety equipment/safety gear requirements for Canadian trail systems (e.g., maximum width 66 inches; maximum weight 2,100 pounds; mirrors and safety gear noted above). Additionally, each Participant is separately responsible for arranging and paying for his or her own transportation to the Quebec starting point-of-origin designated for the trip, as well as obtaining the mandatory Quebec Trail Permit covering the days of Participant's trip.
- 5. Each Participant must comply with STQ's policies concerning ATV/UTV requirements, safety gear, trip planning, and daily riding schedules, which are explained on STQ's website (snowtourquebec.com and/or quadtourquebec.com) and incorporated herein by reference.
- 6. Price and Cancellation Unless otherwise arranged, each trip will be limited to ten ATV/UTV vehicles. Based on current estimates, the average projected final price each Participant will pay to STQ for the trip is between \$1,225 and \$2,000 U.S. Dollars ("USD") (depending on trip and double/single occupancy selection and exclusive of the costs and expenses for which the Participant is personally responsible).
